Due to ill health/disability I couldn't do the job I trained for and joined a local disability parent group and helped to grow the charity across Sunderland, this was my stepping stone into the world of disability, the needs that disabled people have and how I could "tell it like it is" at regional and local health forums and meetings.

I became the voluntary sector rep at the Strategic Health meetings, and more recently as one of the Voluntary sector reps for Washington at the area meetings.

My working adult life has seen me manage small disability charities such as Wearable and now Headway Wearside, a charity supporting those with brain injury and their carers.



For many years I have fought to have disability on the agenda to ensure accessibility for everyone to enable them to access local services working alongside the NHS, Transport and Local Authority leisure services to name a few.

I have attended several “an afternoon” at parliament to highlight the need for rehabilitation services to be implemented into mainstream health services.
